### **Permits:**

The Montgomery County Department of Environmental Protection requires homeowners to obtain building permits for installation of additions, decks, fences, skylights, hot tubs, patios, sheds and other alterations. The AFRC reserves the right to contact County agencies to verify compliance with code and permit requirements, and to seek enforcement of these regulations to ensure construction is performed in a safe and legal manner.

County regulations require that homeowners in the community obtain AFRC approval PRIOR to obtaining the necessary building permits. Failure to comply with these regulations may be a criminal violation, and enforcement may be referred to legal authorities.

Signatures:

Obtain the signatures of ALL homeowners who share property lines with you and who will have a direct view of this change. A minimum of two (2) signatures must be obtained. In the event that property lines are not shared with more than one (1) other property, you must obtain at least one (1) other signature from a neighbor who will have a direct view of the change. In the event that a required signature can not be obtained, the AERC will arrange fro proper notification.

This process may extend the time normally required to approve an application. Attach additional signature information, as necessary.

**NOTE:** Signatures do not constitute approval or disapproval of the changes described in this application, they merely indicate an awareness of the proposed changes. Homeowners may contact any member of the AERC to protest a proposed change. Protests should be in writing, and must be delivered within ten (IO) days of the date signed.
